This month's Banner is dedicated to the memory of Supreme Court Justice Ruth Bader Ginsburg, who passed away on Friday, September 18<sup>th</sup>. Justice Ginsburg was a modern-day suffragette who dedicated her entire life to making the world better for all women and girls.

Ginsburg was born and grew up in Brooklyn, New York. Her older sister died when she was a baby, and her mother died shortly before Ginsburg graduated from high school. She earned her bachelor's degree at Cornell University and married Martin D. Ginsburg, becoming a mother before starting law school at Harvard, where she was one of the few women in her class. Ginsburg transferred to Columbia Law School, where she graduated joint first in her class. During the early 1960s she worked with the Columbia Law School Project on International Procedure, learned Swedish and co-authored a book with Swedish jurist Anders Bruzelius; her work in Sweden profoundly influenced her thinking on gender equality. She then became a professor at Rutgers Law School and Columbia Law School, teaching civil procedure as one of the few women in her field. (Wikipedia)

## National Business Women's Week – Nancy Werner



National Business Women's Week was established to honor the contributions of working women and their families. The concept originated with Emma Dot Partridge, Executive Secretary of the National Federation of Business and Professional Women's Clubs from 1924 to 1927.

The first annual observance of NBWW was held April 15-22, 1928 when National President Lena Madesin Phillips opened the week with a nationally broadcast speech. She stated that the purpose of the week was "to focus public attention upon a better business for a better business world."

It was in 1938, NBWW was moved to the third full week of October. U.S. President Herbert Hoover was the first president to issue a letter recognizing NBWW and the contributions and achievements of the working women. The celebration of National Business Women's Week has helped to promote leadership roles for women and to increase opportunities for their advancement professionally and personally.

The Central Montgomery County BPW has always participated in this week's celebration with sharing the proclamations from the Governor (included), proclamation from our State Representative and proclamation from the Montgomery County Commissioners. We try to provide displays in the area libraries (thank you Noreen and Becky). Lastly, we try to honor a Woman of the Year or Employer of the Year to highlight the good works of these individuals relating to NBWW. This year the time frame will be October 18 to 24.

Two of Montgomery Township's most well-known women have both earned high honors.

The township's supervisors recognized District Judge Andrea Duffy and longtime employee Ginny Bailey for earning high honors with the Pennsylvania Federation of Business and Professional Women's Clubs this summer. "It is a night for recognizing outstanding efforts, not only of our township personnel, but also of some outstanding citizens," said supervisors' Chairwoman Tanya Bamford.

Duffy, the township's district judge since 2012, was honored by the BPWPA with their "Public Servant Award" during their 100th annual convention, held virtually on June 13, according to supervisor Beth Staab, who said the judge earned recognition from the group via her non-profit "Drug Addiction Resource Alliance," which presents seminars and connects residents with resources to fight addiction across the region. Duffy earned the recognition "for her work with DARA, and the 'Liberty and Law' civics classes she conducts in the elementary schools in the North Penn School District," said Staab.

Bailey, a longtime employee of the township's parks and recreation department and community and recreation center, earned the BPWPA's "Woman of the Year" award for her longtime involvement with the BPWPA, including her role as vice president of the group's Central Montgomery County chapter. "This is the highest honor that the BPWPA can bestow, in recognition of contributions to the advancement and ideals of the Pennsylvania Federation of Women," Staab said.

## October is Domestic Violence Awareness Month



Laurel House asks, “Have you ever wondered why purple is the color associated with domestic violence? According to [domesticshelters.org](http://domesticshelters.org), purple, white, and gold were used in the early 1900s when the women’s suffrage movement adopted the National Women’s Party’s colors. The colors started in England and symbolized purity, hope, and loyalty. Then, on July 9, 1978, nearly 100,000 advocates of equal rights for women marched in Washington, D.C., many dressed in lavender.

In October 1981, when the National Coalition Against Domestic Violence observed a “Day of Unity,” many of those participants also chose to wear lavender or purple. In October 1987, the first Domestic Violence Awareness Month was observed, and again, purple-hued clothing was widely embraced by participants. This progression solidified the adoption of purple for marketing and awareness purposes by domestic violence organizations; purple was chosen as an evolution of the lavender from decades past.

**Wear purple on Thursday, Oct. 22nd to raise awareness and show support for survivors of domestic violence.**

## Election Information

With less than one month until Election Day, here are answers to some of the frequently asked questions (Courtesy of WHY-PBS):

### How can I know that my mail-in vote has been counted?

When your county election office receives your ballot, they'll scan it, and you should get an email letting you know it has arrived. But as of now, the county can't actually process or tabulate any ballots until Election Day, so there won't be any more updates until then. Pennsylvania has no statewide rules requiring counties to inform voters if their ballot is rejected for some reason. However, Gov. Tom Wolf has instructed counties not to reject mail ballots if voters' signatures don't match the ones on file, so that's one reason that should not be a factor.

### Why is the Department of State's ballot tracker showing an incorrect status?

If you've been closely monitoring the status of your ballot using the Department of State's ballot tracker, you might have seen that there have been delays in its updates. If you've read this far, send Ginny and email. The DOS is aware of this problem. A spokeswoman, Wanda Murren, said that the tracker's accuracy depends on counties regularly updating their data, and that hasn't always been happening in these early days of ballot returns. "As more ballots are mailed in the weeks to come, the tracker will more accurately reflect each county's activity and the status of individual voters' ballots," she added.

### What do I do if I requested a ballot, but decided that I want to vote in person?

The good news is you have options. State law allows you to bring your (unmarked!) ballot and its envelope to your polling place, where you can surrender it to poll workers and proceed to vote on a machine. You can also cast a provisional ballot at your polling place if you lose your mail ballot, or don't receive it for some reason. However, if you receive your mail ballot and have time to submit it, either in person or via the postal service — USPS recommends mailing it at least a week before the election — you should feel confident using those methods. They're quick and easy, and as long as you follow your mail ballot instructions carefully, your vote should be counted and you won't have to risk a crowded polling place on Election Day.

### When will we have results?

There are a lot of moving parts, but basically, this will depend on (1) when counties can start processing mail ballots, and (2) how close the race is. Right now, Pennsylvania law dictates that county officials can't start processing mail ballots until 7 a.m. on Election Day. Those officials are pushing the legislature to let them start earlier, but so far, they haven't come to a consensus on a bill to do that. If the presidential race is a blowout, we may not need as complete a count to be able to say confidently who won. But if, for instance, it comes down to slim margins in a few key states, and Pennsylvania is one of those states, the results could hang on the commonwealth getting its count done.

Have a plan, make sure your voter registration is current, research the candidates, and be an informed voter. Regardless of your party, who you vote for, or whether you decide to vote in-person or by mail-in ballot — **VOTE!**
